CHAT provides a myriad of programs that include an independent high school, a pre-school, after school tutoring, life skills classes, leadership training, mentoring, student led entrepreneurships, summer camps and more.

CHAT's tutoring program served an average of 75 youth using 55 volunteers every Monday and Tuesday. Wednesday life skills classes served and average of 70 youth using 42 volunteers. During the summer, CHAT hosted 16 interns, living in the community and assisting with the summer day camps serving approximately 60 youth. 29 student leaders were selected for leadership positions over the summer, serving in CHAT's summer camps and as entrepreneurs working with woodworking, screen printing and urban farming agricultural businesses.

4b (Code:) (Expenses \$ 559,387 including grants of \$) (Revenue \$ 559,387) Church Hill Academy - The Academy provided 31 high-school students with an individualized and holistic private Christian education during the 2015-2016 school year. The Academy held its sixth graduation ceremony for five of its students in June 2016. Over 200 people attended the ceremony to celebrate the achievements and futures of these youth. Graduates are have gone on to pursue work and further education at institutions including Longwood University, Richard Bland College, Virginia State University and J. Sargeant Reynolds Community College.
